Item 2 - Minutes

Item 3 - Matter Arising

There being no other matters arising the Chair moved to the next item of business.

Item 4 - Project Update Report - Confidential

The Development Officer updated the meeting on the current status of the project. He informed the group that the evaluation of the final tender could not be completed until the outcome of the NIROCs Consultation was known. The NIROCs consultation had been extended for an additional week but it was not yet known when the outcome would be published.

He further informed the meeting that the Chair, the project manager and he had met with Minister Foster on the issue and that they had had a very satisfactory meeting. The Minister had agreed to support the position outlined by the Group on this matter, however, representation could only be made after the consultation had closed.

Councillor Gallagher stated that this delay has been very unsatisfactory and asked how the bidder regarded this matter. The Development Officer told the members that the bidder has been made aware of this in December 2011as soon as the matter had come to the attention of the Group; he added that as this was a UK wide matter everyone is faced with the same issue.

Item 5 - Update on the award of the Mixed Dry Recyclables Contract - Confidential

The Development Officer stated that he was continuing to liaise with the advisors on this matter and that Regen is reissuing the Writ naming all 7 councils.

He stated that the process was to seek clarification from the successful bidder and upon receipt of this information a recommendation would be brought to the Joint Committee as to how to proceed in the matter.

Item 6 - Presentation to the Environment Committee of the NI Assembly 19th January 2012

The Development Officer updated members on the presentation to the Environment Committee and he thanked those members of the Joint Committee who had attended the session. He informed the meeting that they had had to adjust the approach to the session due to time constraints but felt that the team had given robust and correct answers to the questions asked.

The Development Officer said he was confident that the Environment Committee had been given full information on the project and that the Department of the Environment would attend a similar session in the coming week.

Mr McVicker told the members that the group was very constricted but gave full and frank answers and he felt that there were a lot of encouraging nods.

The Chair stated that the message had been delivered very effectively and Alderman Coyle said that he would like to thank the officers and members as a great deal of work had been put into preparing for the event.

Item 7 - Submission to the DETI consultation on NIROCs

Mr Gray took members through the submission to the above consultation. He highlighted the background, process and conclusion and stated that if the proposed changes are applied to the infrastructure project many benefits would be lost.

The NWRWMG had asked that NIROCs legislation should allow for any Advanced Gasification or Pyrolisis generating station that either was in the Public Procurement process, or for which a valid planning application had been lodged prior to the date of this consultation, to be able to qualify for accreditation for ROC's under the extant definitions up to March 2017.
