### **Item 1 - Declaration of Members' Interests**

### **Item 2 - Minutes of the Joint Committee 15<sup>th</sup> July 2015**

The chair reviewed the previous minutes with the Committee.

### **Item 3- Matter Arising**

The Chair, on behalf of the Group, offered congratulations to Derry City & Strabane District Council for their 'Council award for Excellence in Waste Management' from Sustainable Ireland for the Recycling & Transfer Station at Strahan Road.

The Clerk reminded members that at the last Joint Committee meeting Councillor Fitzpatrick had requested a complete breakdown of the existing Service Contracts. The Clerk presented a paper to members regarding the Service Contract and stated that some of the contracts were up for renewal.

The Clerk informed members that the DoE were looking at potential ways forward to minimise waste crime.

He stated that the DoE and DETI are exploring opportunities for processing recyclables within the island.

A discussion then ensued.

There being no other matters arising the Chair moved to the next item of business.

### **Item 4- Waste Resource Action Programme (WRAP) Presentation**

Dr Garner gave a presentation to the Joint Committee entitled WRAP Local Authority Support (presentation attached as appendix 1).

### **Item 5- Delivery of Regional Waste Management - update**

The Clerk informed members that at the last Waste Programme Board meeting in June the topic of Regional Waste Management was discussed and a review is on-going.

He also informed members that the waste co-ordination group had met recently and was working towards improving communications between councils and the NIEA regarding enforcement actions/notices and other related matters. He added that the department and the Chief executives had agreed that the membership of this group should be extended to include Directors from all eleven Councils in order to strengthen relationships between central and local government.

### **Item 6- Residual Waste Tender and Kerbside Commingled Recyclables Tender - update**

The Clerk stated that the tenders for Residual Waste and Street Sweepings have been advertised in the regional press and the official European Journal and are currently under evaluation. He added that it is the intention that a recommendation on both tenders will come forward to the next meeting of the Joint Committee.

The Kerbside Commingled Recyclables Tender will be advertised in the coming days.

The Clerk informed the Committee that Mid Ulster District Council will also be a participant in the tender exercise.

### **Item 7 - Corporate Risk Register**

The Clerk referred to the attached Corporate Risk Register for members' information.

He stated that there has been no additional risks identified, no risks closed and no other changes have been made to the Risk Register since July 2015.
