Item 2 - Minutes of the Joint Committee 18th October 2017

The Clerk reminded members of the Outlined Business Case commissioned by the five councils namely Causeway Coast and Glens Borough Council, Derry City and Strabane District Council, Fermanagh Omagh District Council, Mid Ulster District Council and Armagh City, Banbridge and Craigavon Borough Council.

He took members through the completed report and advised that the report will be presented to each member council with a recommendation on the next stage.

Item 6 - Confidential - Tender Report Local Authority Collected Kerbside Commingled Recyclables

The Clerk presented a report on the provision of NWRWMG Local Authority Collected Kerbside Commingled Recyclables for members' consideration.

The Clerk asked the committee to consider the results of the evaluation and recommend to the individual member councils the following:

- Lot 1 Regen Waste Limited for Causeway Coast and Glens Borough Council.
- Lot 2 RecyCo Limited for Derry City and Strabane District Council.
- Lot 3 RecyCo Limited for Mid Ulster District Council.
- Lot 4 Regen Waste Limited for Mid Ulster District Council.
- Lot 5 RecyCo Limited for Fermanagh and Omagh District Council.
- Lot 6 RecyCo Limited for Fermanagh and Omagh District Council.

This recommendation was **PROPOSED** by Councillor Hastings and **SECONDED** by Councillor McHugh.

The Chair requested that the meeting come out of Committee. This was **PROPOSED** by Councillor Hastings and **SECONDED** by Councillor McHugh.

Item 7 - Current Status of Tenders

The Clerk stated that the attached was the latest status of NWRWMG tenders and was for members' information.

He informed members that the tender for the disposal of Tyres, item 5 has been evaluated and a recommendation brought forward to councils on the award of contract.

He also informed members that item 7, collection and processing of WEEE and item 8, collection and processing of Batteries will expire at the end of June 2018 and that initial



discussions have taken place with ARC21 on retendering the contract for all eleven Councils.

The Clerk stated that item 9, Collected Kerbside Commingled Recyclables had been presented to the committee under separate report and now covers four council areas, Causeway Coast and Glens, Derry City and Strabane, Fermanagh Omagh and Mid Ulster.

Item 8 - Any other relevant Business

The Chair informed members that as discussed at the last meeting due to clashes with the Waste Government Working Group the next Joint Committee meeting will take place on Tuesday 12th December 2017 in the Limavady offices of Causeway Coast and Glens Borough Council. This was agreed by the Committee.
